

LIMITED LIFETIME WARRANTY

Parlee Cycles, Inc. ("Parlee Cycles") warrants that its bicycle frames, front derailleur hangers, and any other bicycle component that Parlee Cycles manufactures ("Products") will be free of any defects in materials or workmanship for as long as the original purchaser owns the products. This warranty is given solely to the original purchaser of the products and may not be transferred or assigned without the express written consent of Parlee Cycles. Parlee Cycles' liability under this warranty is limited to repair or replacement of defective products.

To take advantage of this warranty the purchaser must register their purchase online at www.parleecycles.com or return the warranty registration card within thirty days of the product's original purchase. In the event of a suspected defect, the purchaser must return the product to a Parlee Cycles authorized dealer for inspection together with proof of its original purchase. The purchaser will bear any and all costs to disassemble and ship the product to the Parlee Cycles authorized dealer. If Parlee Cycles determines that there was a defect in materials of workmanship, and that this warranty otherwise applies, it will repair or replace the defective product, return it to the purchaser at no additional cost to the purchaser, and reimburse the purchaser for the cost of shipping the product to the Parlee Cycles authorized dealer. If Parlee Cycles determines that there is no defect, or that this warranty otherwise does not apply, it will return the product to the purchaser at the purchaser's expense. All costs of reassembly will be the responsibility of the purchaser.

LIMITATION OF LIABILITY. IN NO EVENT WILL PARLEE CYCLES OR ITS DEALERS BE LIABLE FOR SPECIAL, INCIDENTAL, OR CONSEQUENTIAL DAMAGES, EVEN IF PARLEE CYCLES OR ITS DEALERS HAVE BEEN ADVISED OF THE POSSIBILITY OF THE SAME.

Local Law: This warranty gives the purchaser specific legal rights. The purchaser may have other rights that vary with the state, province, or country. To the extent that this warranty and limitation on liability is inconsistent with local law, it will be deemed modified to the extent necessary to comply with local law.

Exceptions to this warranty: This warranty does not apply to any products that have been incorrectly installed or modified or used with other components not authorized by Parlee Cycles. This warranty also does not cover ordinary wear and tear, damage caused by a crash, impact, abuse of the product or use other than for the product's intended purposes. This warranty also does not apply to use as a rental. Paints and Finishes are covered by this warranty for up to one year.

Other Components: Parlee Cycles makes no representations or warranties with respect to components of other manufacturers, whether supplied with the products or purchased separately. These components are warranted, if at all, by their manufacturers and suppliers.

The terms of this warranty and limitation on liability may not be altered or enlarged without the express, written consent of Parlee Cycles.

Crash Replacement Program: 25% discount off retail MSRP frameset price to the consumer.

Parlee Cycles offers a Crash Replacement Program for the original owner of a Parlee frameset that is damaged beyond use and not covered by warranty. The Crash Replacement Program is for a Parlee frameset only. (Complete bikes are not authorized on this program offer) The program is not transferable and only applies to the original owner of the affected Parlee Cycles frameset for a period in time not to exceed three years time from the date of original purchase.

Note: The Crash Replacement Program is to the consumer. We offer a reciprocal discount to any Dealer working with a consumer on a crash replacement frameset at 25% off the standard wholesale price. We do not offer any crash replacement discounts to Distributors on this program.
